FOP BY-LAWS: ARTICLE 13, SECTION 2

Any candidate having been notified of his or her election to membership in this lodge and shall fail to present themselves for admittance to membership within three (3) months from the date of said election, through no fault of the lodge, shall forfeit all rights under said election unless reasons are given that are satisfactory to the lodge and the time limit is extended by the lodge. In such event, the initiation fee shall be refunded to said candidate with explanation as to the reason for said election.

This just means that within 3 months after becoming a member, you must come out to the lodge during a meeting to be sworn in. At that time, you will be given a copy of the by-laws and other items entitled to members.
